3121. Sustainability Powys

A meeting was held on the 12th February at Tirabad Hall. In attendance: Gwilym Davies (Powys) led the meeting of two councillors from Llangammarch, three from Llanwrtyd, one from Cilmeri, one from Llanafan Fawr, one from Aberedw and one from Builth, plus three Council Clerks. Three of the councillors present were also County Councillors. The idea of six hubs in Powys was strongly opposed as it would represent loss of representation for everyone. The centralisation of services (health, leisure, libraries etc) was opposed as travelling to Llandrindod is not easy, public transport is not straightforward.
